ABSTRACT: This paper reviewed a theoretical perspective for addressing individual differences among Nigerian students using inclusive and differentiated instructional strategies. The model is based on established learning theories such as Gardner's theory of multiple intelligences and Vygotsky's sociocultural theory. It highlighted the relevance of recognizing students' unique learning styles, backgrounds, and abilities to improve teaching effectiveness and student outcomes. It also outlined key strategies including flexible grouping, continuous assessment, culturally responsive teaching, and student-centered learning. Challenges such as limited teacher training, large class sizes, and policy-practice gaps were also discussed. The proposed perspective offers a practical guide for educators, policymakers, and teacher trainers to promote equity and enhance learning experiences for all students in Nigeria's diverse classrooms.

INTRODUCTION

Education is universally recognized as a key driver of personal growth, national development, and societal transformation. However, the effectiveness of any educational system greatly depends on how well it recognizes and accommodates the individual differences among learners. In a typical Nigerian classroom, students differ in terms of intellectual abilities, socio-economic backgrounds, cultural values, learning styles, emotional development, linguistic diversity, health conditions, motivation, interests, and prior knowledge. These factors shape how each student processes information, interacts with others, and engages with learning materials (Adebayo & Tukur, 2021).

Over the years, education in Nigeria has largely followed a standardized and rigid instructional model, with little or no adaptation to the diverse learning needs of students. Classrooms are structured around a common curriculum and teachers often adopt uniform teaching methods, such as lectures and note copying. While these methods may serve average or

high-achieving students, they often leave behind those who learn differently, slowly, or require special support. Unfortunately, this standardized approach fails to reflect the complex realities of the modern learner, especially in multicultural, multi-lingual, and economically stratified societies like Nigeria (Eze & Onwuegbuzie, 2019; Uzoeshi & Akpan, 2020).

In Nigeria, the challenge of addressing individual differences is made worse by overcrowded classrooms, limited instructional materials, underqualified teachers, and a lack of training in inclusive pedagogy. Many classrooms hold between 50 to 100 students, making it extremely difficult for teachers to provide individual attention. In addition, many teachers are not adequately trained to differentiate instruction or identify learning disabilities and special needs (Okoye & Aghaulor, 2018). The traditional approach to teaching, which prioritizes rote memorization and examination scores, continues to dominate the instructional space despite growing awareness of learner diversity.

Meanwhile, the 21st-century learner is expected to be creative, collaborative, technologically literate, and self-directed. Addressing individual differences, therefore, becomes more than a classroom necessity it becomes a strategic tool for national development. When students are taught according to their strengths and learning needs, they are more likely to stay in school, achieve academic success, and become useful members of society (UNESCO, 2020; Federal Ministry of Education, 2021).

Globally, educational theorists and psychologists have long emphasized the relevance of individual differences in shaping instruction. For instance, Howard Gardner's theory of multiple intelligences (2011) encouraged educators to move beyond the traditional focus on linguistic and logical-mathematical abilities by recognizing other forms of intelligence such as musical, spatial, interpersonal, and bodily-kinesthetic. Daniels (2016) opined that Lev Vygotsky's sociocultural theory stresses the role of social interaction, culture, and language in cognitive development, suggesting that learners thrive in environments where teachers scaffold instruction based on each student's "zone of proximal development". Similarly, Tomlinson's differentiated instruction model (2017) emphasized tailoring content, process, and product to suit students' readiness, interests, and learning profiles.

These theories provide useful foundations, but many of them were developed in Western contexts. While their core ideas are universally relevant, Nigeria's unique socio-cultural, economic, and educational landscape calls for a context-specific model that can help teachers apply inclusive teaching strategies effectively. A theoretical model that addresses individual differences in Nigerian classrooms must consider local realities, such as limited funding, diversity in native languages, regional disparities in education, and teacher workload (Akinade & Ojo, 2023).

Furthermore, the United Nations' Sustainable Development Goal 4 emphasizes "inclusive and equitable quality education and lifelong learning opportunities for all." This global call makes it clear that no learner should be left behind, regardless of background or ability. To meet this target, Nigeria must move beyond theory and actively develop practical models for managing learner diversity across all levels of education (UNESCO, 2020). Evidence from recent studies indicates that students learn best when instruction is individualized or adapted to their needs. This does not mean giving every student a different lesson, but rather offering flexible approaches that make it easier for all learners to understand. These may include using visual aids, group activities, technology-based learning, cooperative learning, personalized assessments, and peer tutoring (Igbokwe & Nwankwo, 2016; Adebayo & Tukur, 2021).

Despite numerous teacher development programs and reforms introduced by the Nigerian government in recent years, there remains a disconnect between policy and classroom practice. Many teachers lack ongoing professional support and are unsure how to implement inclusive and differentiated instruction in large, under-resourced classes. Without a guiding model, teachers often rely on outdated methods that fail to address the needs of all students, especially those with learning challenges or from disadvantaged backgrounds (Adegboye, 2017; Okoro & Emeka, 2022). This paper, therefore, sought to fill a critical gap by proposing a theoretical model that integrates global best practices with local Nigerian realities. The model aims to provide a framework for educators to identify, understand, and respond to individual differences in meaningful and sustainable ways. With such a model, teachers can create more inclusive classrooms where all students regardless of ability, background, or learning style are supported to reach their full potential.

THEMATIC ANALYSIS

Individual Differences

The concept of individual differences refers to the distinct and measurable variations that exist among people in terms of their physical, cognitive, emotional, social, and psychological attributes. In educational contexts, it describes the fact that learners differ significantly in the ways they absorb, process, and respond to information. These differences are shaped by a range of intrinsic and extrinsic factors, such as heredity, environment, culture, socioeconomic background, health, personality, intelligence, and life experiences. As a result, no two students are exactly alike, even if they share similar classroom experiences, age, or cultural backgrounds (Santrock, 2018).

In educational psychology, individual differences are regarded as a fundamental aspect of human development. Researchers and educators alike agreed that recognizing and addressing these differences is essential to creating effective teaching strategies and inclusive learning environments. This view stems from the understanding that learners enter the classroom with varying levels of prior knowledge, different rates of learning, distinct interests, and diverse needs. Consequently, a uniform approach to teaching often fails to cater for the unique needs of all learners, leading to unequal educational outcomes (Santrock, 2018).

The recognition of individual differences has its roots in early philosophical and psychological thought. Philosophers such as Plato and Aristotle acknowledged that individuals vary in their talents and aptitudes. In modern psychology, scholars like Francis Galton, Alfred Binet, and Jean Piaget explored the dimensions of human intelligence and cognitive development, thereby laying the foundation for contemporary understanding of individual variation. The development of intelligence testing in the early 20th century, especially by Alfred Binet and Theodore Simon, further advanced the empirical study of individual cognitive differences, helping educators to better identify and address students' learning needs.

One of the most influential educational theories that incorporates individual differences is Howard Gardner's theory of multiple intelligences. Gardner (2011) pointed out that intelligence is not a single general ability but a collection of multiple intelligences, such as linguistic, logical-mathematical, spatial, bodily-kinesthetic, musical, interpersonal, intrapersonal, and naturalistic intelligences. Gardner's theory emphasizes that every individual possesses a unique blend of these intelligences, and that teaching strategies should be adapted to align with these diverse

cognitive strengths. This perspective reinforces the idea that educational practices must be responsive to the variety of ways students learn and demonstrate understanding.

Furthermore, the concept of learning styles supports the importance of individual differences in the classroom. Learning styles refer to the preferred ways in which individuals engage with content. While some learners understand best through visual representation, others may prefer auditory explanations or kinesthetic experiences involving hands-on activities. Although the scientific basis for fixed learning styles has been debated in recent years, the broader implication remains clear: students have different preferences and strengths when it comes to learning, and instruction should be flexible and diversified to meet these needs (Pashler et al. 2017).

In addition to cognitive and learning differences, students also differ in their emotional and psychological dispositions. Emotional intelligence, motivation levels, self-esteem, stress tolerance, and anxiety all play significant roles in how students respond to academic challenges. A learner who is highly motivated and emotionally resilient may perform well even in less-than-ideal conditions, while another with low motivation or anxiety may struggle despite having the intellectual capability. These emotional and psychological differences necessitate a holistic approach to education that supports students not just academically but also emotionally and socially (Goleman, 2015).

In multicultural societies such as Nigeria, cultural and linguistic diversity further compounds individual differences among learners. Nigeria's rich ethnic, linguistic, and religious diversity means that students bring varied cultural norms, values, and prior experiences to the classroom. These cultural factors influence their communication styles, interactions, perception of authority, and general approach to education. For instance, a student from an urban area with access to modern learning resources may perform differently from a peer in a rural community with limited educational infrastructure. Moreover, language of instruction can present challenges for students who do not speak the dominant language fluently, thus affecting their academic performance. Addressing individual differences in such settings requires culturally responsive pedagogy that respects and incorporates learners' backgrounds into the teaching and learning process (Okoro & Emeka, 2022).

AREAS OF INDIVIDUAL DIFFERENCES AMONG NIGERIAN STUDENTS

Learners differ in various ways that influence how they perceive, interpret, and respond to educational experiences. These differences, often referred to as individual differences, encompass a broad range of characteristics. Recognizing and responding to these variations is essential in fostering inclusive and effective teaching. The major areas where individual differences commonly occur among learners include intellectual ability, learning styles, personality traits, interests and motivation, prior knowledge and experiences, physical and health conditions, emotional and psychological makeup, language background, and socio-cultural context:

One of the most prominent areas of individual differences among learners is intellectual capability. Intellectual capability refers to a student's general mental capacity for reasoning, problem-solving, learning, and adapting to new situations. Students vary widely in their cognitive strengths and weaknesses. While some grasp abstract concepts quickly and can analyze complex problems with ease, others may require more time, simplified explanations, or concrete examples to understand the same concepts. Traditionally, intelligence was measured using standardized IQ tests, but modern perspectives, such as Gardner's (2011) theory of multiple

intelligences who argued that intelligence is multifaceted and includes linguistic, logical-mathematical, spatial, bodily-kinesthetic, musical, interpersonal, intrapersonal, and naturalistic intelligences. This broader view encourages educators to recognize that students may excel in different intellectual domains and should not be evaluated based solely on linguistic or mathematical performance.

Learning styles refer to the preferred methods and strategies that individuals use to absorb, process, and retain information. Although the concept has been debated in recent academic discourse, many educators still observe that students show preferences in how they learn best. Common learning styles include visual (learning through images, charts, and spatial understanding), auditory (learning through listening and verbal instructions), and kinesthetic (learning through hands-on experiences and physical activities). Acknowledging these preferences allows teachers to vary their instructional strategies using videos, discussions, experiments, and role-plays to cater to the learning needs of diverse students in the classroom (Pashler et al. 2017).

Personality differences among learners significantly affect their behavior, attitude, and interaction in learning environments. Personality includes consistent traits such as introversion vs. extroversion, emotional stability, openness to experience, conscientiousness, and agreeableness. These traits influence how students approach learning tasks, handle academic pressure, and engage with peers and teachers. For example, an extroverted learner might participate actively in group work and class discussions, while an introverted student may prefer working independently. Teachers must understand and respect these personality differences to foster an emotionally safe and motivating classroom environment that allows all learners to thrive.

Interests and levels of motivation vary widely among learners and play a crucial role in their academic engagement and performance. Some students show high intrinsic motivation, meaning they are driven by curiosity and a love for learning. Others are more extrinsically motivated, relying on rewards, recognition, or fear of failure. Likewise, students may have specific subject preferences, such as a natural inclination toward science, literature, sports, or the arts. When instruction connects to learners' interests and goals, it becomes more meaningful and engaging. Therefore, understanding students' interests and what motivates them enables teachers to plan lessons that resonate with learners and stimulate sustained attention and effort (Ryan & Deci, 2017).

Every learner enters the classroom with a unique set of experiences and prior knowledge that shapes how they interpret new information. This includes not only academic background but also life experiences gained from family, community, religious practices, media exposure, and informal learning. Students with rich exposure to reading materials or stimulating conversations at home may demonstrate greater readiness for academic tasks compared to their peers who have had limited exposure. These differences impact comprehension, vocabulary development, and conceptual understanding. Effective teachers use diagnostic assessments or questioning techniques to gauge students' prior knowledge and build upon it when introducing new content (Bransford et al. 2000).

Learners also differ in terms of physical and health conditions, which can significantly affect learning ability and participation. This includes students with disabilities (such as visual, hearing, or mobility impairments), chronic illnesses, and temporary health conditions. Some students may also have neurodevelopmental disorders such as dyslexia, attention-deficit/hyperactivity disorder (ADHD), or autism spectrum disorder (ASD). These conditions can

create barriers to learning if not properly addressed. Inclusive education practices require that teachers make necessary accommodations such as assistive technologies, modified materials, or flexible instructional strategies to ensure equitable learning opportunities for all students, regardless of physical or health limitations (UNESCO, 2020).

The emotional and psychological state of learners significantly influences their academic performance and behavior in the classroom. Factors such as self-esteem, self-confidence, anxiety, stress tolerance, and emotional resilience vary from one student to another. For instance, a student who feels secure and valued in school is more likely to take intellectual risks and engage in classroom activities, while one who struggles with low self-worth or anxiety may avoid participation and perform poorly. Teachers who are emotionally attuned to their students' needs can create a supportive environment that fosters emotional well-being and encourages academic risk-taking (Goleman, 2015).

Learners come from diverse socio-cultural and economic backgrounds that influence their values, beliefs, learning habits, and access to educational resources. according to Ololube (2011, 2012), a child from a well-resourced, educated family may have access to books, the internet, and parental academic support, while another from a low-income household may lack these opportunities. Cultural factors also affect learners' perspectives, behaviors, and classroom interactions. For example, some cultures emphasize collective learning and respect for authority, while others promote independence and inquiry. Recognizing these differences helps teachers avoid bias and design culturally responsive teaching practices that validate and incorporate students' diverse cultural identities.

THE CAUSATIVE FACTORS IN INDIVIDUAL DIFFERENCES

Individual differences in Nigerian classrooms are multifaceted and arise from a combination of factors that stem from both external and internal influences. These differences, which can manifest in various ways such as cognitive abilities, socio-economic backgrounds, cultural norms, and personal experiences, significantly affect how students learn and perform academically. Understanding the causes of these differences is crucial for educators who aim to adopt teaching strategies that meet the diverse needs of their students. Below are the primary causes of individual differences in Nigerian classrooms:

Socio-Economic Background

One of the most prominent causes of individual differences in Nigerian classrooms is the socio-economic background of the students. In Nigeria, there is a wide disparity between students from wealthy and economically disadvantaged families. Children from higher-income households often have access to better educational resources, such as textbooks, private tutors, and access to modern technology, which contribute to their academic success. In contrast, students from lower-income families may struggle to afford basic educational materials, and their parents may not have the financial means to support their education through private lessons or extra-curricular activities (Okoye & Asogwa, 2021). These disparities create significant gaps in academic achievement, as well-resourced students often perform better than their less-privileged counterparts.

Cultural and Linguistic Diversity

Nigeria is one of the most culturally and linguistically diverse countries in the world, with over 500 different languages spoken across its regions (Ololube, 2011). Vast cultural and linguistic diversity often contributes to individual differences in Nigerian classrooms. Many students come from ethnic groups with their own languages, traditions, and learning styles. In Nigerian classrooms, students may be required to learn in a language that is not their first language, which can lead to difficulties in comprehension, communication, and academic performance. For instance, students from the Yoruba, Igbo, or Hausa-speaking communities might find it challenging to learn in English, which is the official language of instruction in most schools. This language barrier can affect students' ability to understand the lessons, participate in classroom discussions, and complete assignments. Additionally, cultural differences may influence students' social behavior, learning preferences, and responses to teaching methods. Some students might be more accustomed to rote memorization, while others might be more comfortable with interactive learning methods, such as group discussions or hands-on activities.

Gender Differences

Gender is another factor that contributes to individual differences in Nigerian classrooms. Traditional gender roles in Nigerian society can impact students' learning experiences. In some regions of the country, there are cultural expectations that prioritize the education of male children over female children, leading to gender disparities in school attendance and performance. This is especially true in rural areas where parents may feel that investing in the education of boys is more beneficial than investing in girls (Ajibola, 2021). Moreover, there are often gender-based expectations related to behavior, with boys and girls being encouraged to excel in different subjects. For example, girls might be steered toward subjects like home economics, social studies, or arts, while boys are encouraged to pursue science, technology, engineering, and mathematics (STEM) subjects. These gendered expectations contribute to differences in academic interests, strengths, and performance. Female students may feel less confident in pursuing traditionally male-dominated fields like engineering or mathematics, while male students might be discouraged from engaging in subjects like the arts or humanities.

Cognitive and Learning Abilities

Cognitive differences among students in Nigerian classrooms are one of the most significant causes of individual differences. Every student possesses unique cognitive abilities, which affect how they process information, solve problems, and retain knowledge. These cognitive abilities include intelligence, memory capacity, attention span, and problem-solving skills. Some students may have higher intellectual abilities, enabling them to understand complex concepts more easily, while others may struggle with basic learning tasks (Ololube, 2012). Learning abilities also vary from one student to another. Some students are visual learners, meaning they absorb information more effectively when it is presented through images, charts, or videos. Others may be auditory learners, benefiting from verbal instructions and discussions. There are also kinesthetic learners who learn best through physical activities and hands-on experiences. However, in Nigerian classrooms, teaching methods are often generalized and may not cater to the diverse learning styles of students. As a result, students with specific learning preferences may not perform to their best ability in a traditional, one-size-fits-all classroom setting.

Family Structure and Parental Involvement

The family structure and the level of parental involvement in a child's education are important determinants of individual differences among students. Students from single-parent households may face unique challenges that impact their academic performance, such as financial instability, emotional stress, or lack of academic support at home. On the other hand, students from well-structured families with involved parents often benefit from a supportive learning environment that encourages academic success. Parental involvement in a child's education has been shown to positively influence academic outcomes. Parents who are actively engaged in their children's education whether through helping with homework, attending parent-teacher conferences, or encouraging learning at home can help bridge the gap in individual differences (Ololube, 2012). However, in many Nigerian families, especially those from disadvantaged backgrounds, parents may not have the time, resources, or education to support their children's academic progress effectively. This lack of involvement can exacerbate the learning challenges faced by students and contribute to disparities in academic achievement.

THEORETICAL PERSPECTIVE

Howard Gardner's Theory of Multiple Intelligences

Howard Gardner's Theory of Multiple Intelligences, introduced in 1983, revolutionized the way educators think about intelligence. Gardner proposed that intelligence is not a single, fixed ability but rather a collection of different, independent intelligences that individuals can possess in varying degrees. He argued that traditional measures of intelligence, like IQ tests, fail to capture the full range of human cognitive abilities. Instead, Gardner identified at least eight distinct intelligences that reflect the diverse ways people process information and solve problems. These intelligences include linguistic intelligence, logical-mathematical intelligence, spatial intelligence, musical intelligence, bodily-kinesthetic intelligence, interpersonal intelligence, intrapersonal intelligence, and naturalistic intelligence.

For example, linguistic intelligence refers to the ability to use language effectively, either through speaking or writing, while logical-mathematical intelligence involves the capacity to think critically and solve mathematical problems. Spatial intelligence is related to the ability to visualize and manipulate objects in space, which is key for fields like art and architecture. Musical intelligence pertains to the ability to understand and create music, while bodily-kinesthetic intelligence relates to physical movement and coordination. Interpersonal intelligence is the ability to understand and relate to other people, whereas intrapersonal intelligence focuses on self-awareness and understanding one's own feelings and motivations. Finally, naturalistic intelligence involves recognizing and categorizing elements in the natural world, such as plants, animals, and environmental patterns.

Gardner's theory has profound implications for addressing individual differences in Nigerian classrooms. Students in Nigeria, like elsewhere, come from diverse backgrounds and have different strengths. Some students may excel in verbal communication, while others may find their strengths in mathematical reasoning, physical activities, or social interactions. In a typical classroom, this diversity might result in some students feeling disengaged or unsupported if the teaching methods do not align with their personal strengths. Recognizing each student by their unique forms of intelligence has its own advantages, as such, educators can design lessons that cater for a range of learning styles. For instance, a history lesson might include group

discussions for interpersonal learners, written assignments for linguistic learners, and visual aids for spatial learners. Through differentiated instruction, which is an approach aligned with Gardner's theory, teachers can ensure that students are not only engaging with content but are doing so in ways that resonate with their individual abilities.

Implementing Gardner's theory in Nigerian classrooms means providing students with opportunities to express their intelligences in different ways. For example, students who may struggle with reading or writing can engage in tasks that involve drawing, performing, or interacting with peers. Similarly, students who are not as strong in logical reasoning might benefit from more hands-on activities, such as experiments or real-world problem-solving scenarios. By adopting this inclusive approach, educators can better meet the diverse needs of their students and help them achieve their full potential.

Lev Vygotsky's Social Development Theory

Lev Vygotsky's Social Development Theory of (1978) provided another valuable framework for understanding how individual differences shape learning processes. Vygotsky emphasized the social nature of learning, asserting that cognitive development is not an isolated process but one that occurs through social interactions, particularly with more knowledgeable individuals such as teachers, parents, or peers. Vygotsky believed that children's cognitive abilities are shaped by their interactions with others and the cultural tools available to them. One of the key concepts in Vygotsky's theory is the Zone of Proximal Development (ZPD), which refers to the difference between what a learner can do independently and what they can achieve with the guidance of a more capable person. The ZPD underscores the importance of providing support that is just beyond the learner's current abilities but not too difficult that it becomes overwhelming. This scaffolding approach enables students to perform tasks they cannot do alone but can accomplish with the help of a teacher or peer.

Vygotsky's theory also emphasizes scaffolding, which is the process of providing temporary support to students as they learn. Initially, the teacher or more knowledgeable peer helps the learner by offering hints, guidance, or tools to complete a task. As the learner becomes more competent, this support is gradually removed until the student can perform the task independently. This process ensures that learning is always within the learner's ZPD, making the experience both challenging and achievable.

The implications of Vygotsky's theory for addressing individual differences in Nigerian classrooms are significant. In many Nigerian schools, students come from various cultural, linguistic, and socio-economic backgrounds, and their learning abilities can vary widely. Vygotsky's theory encourages teachers to understand where each student is in their learning journey and to provide the right level of support. For example, a teacher can identify a student's current level of understanding and provide scaffolding that helps them move forward. This might involve giving simpler tasks to struggling students or offering more complex tasks to those who are ready for a challenge. Through such support, all students can make progress within their ZPD, regardless of their starting point.

In Nigerian classrooms, where students often face challenges such as language barriers or limited access to resources, Vygotsky's emphasis on social interaction and collaboration can be particularly useful. Peer learning, group activities, and teacher-student interactions are critical in creating an environment where individual differences are addressed effectively. Educators can foster collaborative learning opportunities that allow students to work together, share ideas, and

help each other. This not only allows students to learn from each other but also gives them a chance to work within their ZPD, thereby making learning more effective and inclusive.

Strategies for Addressing Individual Differences in Nigerian Classrooms

Differentiated Instruction

Differentiated instruction is a teaching approach where teachers provide different students with different avenues to learn the same content. It involves adjusting teaching methods, resources, and assessment techniques to accommodate students' diverse learning needs. For example, some students may learn best through visual aids such as charts, diagrams, and videos, while others may benefit from verbal explanations or hands-on activities. In a differentiated classroom, a teacher might offer different versions of a task or lesson, provide extra time for some students, or use varying levels of complexity in activities. This ensures that all learners, regardless of their strengths or weaknesses, can engage with and benefit from the lesson (Tomlinson, 2014).

For instance, if teaching a topic like climate change, a teacher could provide a visual representation (e.g., a video or infographic) for visual learners, while offering a detailed explanation or group discussion for auditory learners. Additionally, kinesthetic learners could be given an activity, such as a hands-on experiment or role-playing exercise, to engage with the topic (Hattie, 2009). Differentiation also extends to assessment strategies. Some students may perform better through written tests, while others might show their understanding through oral presentations or creative projects. This flexibility ensures that all students can demonstrate their learning in a way that best suits their abilities (Tomlinson, 2001).

Learner-Centered Teaching Approaches

Learner-centered teaching focuses on actively engaging students in their own learning process. This approach recognizes that students are not passive recipients of knowledge but active participants who bring their own ideas, experiences, and questions to the classroom. In learner-centered classrooms, students are encouraged to take responsibility for their learning through methods like inquiry-based learning, project-based learning, and collaborative learning (Weimer, 2013).

Inquiry-based learning allows students to explore and investigate topics through questions and problem-solving. Instead of simply presenting information, the teacher guides students in exploring and discovering answers for themselves. This method encourages curiosity, critical thinking, and independent learning, which is particularly beneficial for students who have different interests or intellectual strengths (Bransford et al., 2000).

Project-based learning involves students working on extended, in-depth projects that require them to apply knowledge and skills to real-world problems. This approach can be particularly engaging for students who may struggle with traditional, lecture-based learning.

Working on a project allows students to contribute based on their own strengths whether it's through research, design, presentation, or analysis (Bell, 2010).

Use of Educational Technology

In the 21st century, educational technology plays a significant role in addressing individual differences in the classroom. Technology can be used to personalize learning experiences, providing students with tools that suit their individual needs. Adaptive learning platforms, for instance, use algorithms to adjust content and difficulty levels based on a student's progress and performance (Shute & Kim, 2014).

Technology can also support students with learning disabilities. Tools such as text-to-speech software, speech recognition, and interactive apps can help students with reading difficulties or those who struggle with written expression. In addition, visual or auditory learners can benefit from multimedia resources like videos, animations, and podcasts that provide varied formats of content delivery (Becta, 2008). Moreover, the use of online learning platforms allows students to work at their own pace, revisiting content as needed or advancing more quickly if they grasp the material faster than others. This personalized approach can cater to students who need additional time or those who are ready for more challenging content (Beetham & Sharpe, 2013).

Inclusive Education Practices

Inclusive education refers to practices that accommodate the diverse needs of all students, particularly those with disabilities or special educational needs. The aim is to create an environment where every student feels valued and has the opportunity to learn alongside their peers. In inclusive classrooms, teachers make adjustments to their teaching practices and materials to ensure that all students can participate in learning activities. This might include providing additional support through teaching assistants, using visual aids, or modifying classroom layouts to accommodate students with physical disabilities (Ainscow & Miles, 2008). An important aspect of inclusive education is making accommodations for students with learning disabilities. For example, students with dyslexia may benefit from additional time on assessments or access to audiobooks, while students with ADHD might need strategies to help them focus and manage their attention during lessons. Teachers can address the individual needs of students in an inclusive classroom setting by using differentiated instruction and providing appropriate accommodations (UNESCO, 2005).

Teacher Training and Professional Development

An effective strategy for addressing individual differences in the classroom is ensuring that teachers are well-trained and equipped with the skills needed to recognize and respond to the diverse needs of their students. Teacher training programs should include components on differentiated instruction, inclusive teaching practices, and the use of educational technology (Darling-Hammond, 2006). Professional development opportunities for teachers are equally important, allowing them to continually enhance their skills and knowledge. These opportunities could include workshops, peer learning, and online courses focused on best practices for accommodating individual differences. Teachers should also be encouraged to collaborate with colleagues, share strategies, and discuss challenges in addressing diverse learning needs. This

ongoing professional development helps teachers stay current with the latest research and educational tools that can support all students (Timperley, 2008).

CHALLENGES IN ADDRESSING INDIVIDUAL DIFFERENCES IN NIGERIAN SCHOOLS

Large Class Sizes

One of the significant challenges in Nigerian schools is large class sizes, especially in public schools. In many schools across the country, it is common to have classes with over 50 students, and sometimes even 100 or more. These large numbers make it difficult for teachers to provide individualized attention to each student (Ololube, 2012). Teachers often struggle to address the specific needs of every student, as they are overwhelmed with managing the classroom. As a result, many students particularly those who may require extra support, such as slow learners or students with special educational needs do not receive the necessary assistance and guidance to thrive academically.

Limited Teacher Training and Professional Development

While teacher training is a vital aspect of improving education, many Nigerian teachers face challenges in staying updated with the latest teaching strategies and methodologies that can address individual differences. The existing teacher training programs often focus on traditional teaching methods and may not adequately prepare teachers to handle diverse learning needs (Nwagwu, 2015). Moreover, professional development opportunities are limited, and teachers often do not have access to the latest resources or training in differentiated instruction or inclusive education practices. This lack of ongoing professional development can prevent teachers from using effective strategies to cater to the diverse needs of their students.

Inadequate Learning Resources

Many schools in Nigeria, particularly in rural or underserved areas, face severe shortages of educational resources. The lack of teaching aids, such as books, technology, and visual or audio materials, makes it challenging for teachers to address the different learning styles of their students. For instance, visual learners may struggle in classrooms that lack charts, pictures, or videos, while auditory learners may find it difficult to engage in environments that primarily rely on written content (Adeleke, 2017). The absence of such resources limits the ability of teachers to use diverse teaching methods and may hinder the academic progress of students with different learning needs.

Socio-Economic Disparities

The socio-economic background of students in Nigeria significantly affects their learning experiences and performance in the classroom. Many students come from disadvantaged backgrounds where access to learning materials, support at home, and extra-curricular educational opportunities are limited. These socio-economic factors contribute to disparities in learning outcomes, as students from wealthier backgrounds often have access to better resources and private tutoring, while those from poorer backgrounds struggle with basic learning tools

(Okoye & Asogwa, 2021). These disparities create a significant gap in educational achievement, making it more difficult for teachers to address individual differences equitably.

Cultural and Linguistic Diversity

Nigeria is a culturally diverse country with over 500 languages spoken across its regions (Ololube, 2012). This linguistic and cultural diversity can create challenges in the classroom, especially when teachers are trying to address individual differences. For example, students may come from different ethnic backgrounds and speak various local languages, which can affect their ability to fully comprehend and engage with lessons, particularly if they are taught in a dominant language like English. In addition, students may have different cultural perspectives and learning behaviors, which can affect their responses to teaching methods. Teachers often face difficulties in adapting their teaching styles to cater to this wide range of cultural and linguistic differences.

Lack of Special Education Services

Special education services are crucial for addressing the needs of students with disabilities, but these services are often lacking in Nigerian schools. While some schools in urban areas have special education programs, they are scarce in rural and remote regions. Many schools do not have the necessary infrastructure, trained staff, or materials to support students with physical, learning, or cognitive disabilities (Ajibola, 2021). Without appropriate special education services, students with disabilities are often left behind, unable to receive the tailored support they need to succeed academically.

CONCLUSION

Addressing individual differences among Nigerian students is a vital aspect of creating an inclusive and effective educational environment. By recognizing that each student has unique strengths, learning styles, and needs, educators can tailor their teaching methods to foster better engagement and academic achievement. The application of theories such as Howard Gardner's Theory of Multiple Intelligences and Lev Vygotsky's Social Development Theory offers valuable insights into how to support diverse learners, emphasizing the importance of differentiated instruction, social interaction, and scaffolding. Despite challenges such as limited resources and large class sizes, a commitment to understanding and accommodating individual differences can significantly enhance the learning experience and outcomes for all students, ensuring that every learner has the opportunity to thrive.

Recommendations

The following recommendations are provided:

- Teachers should adjust their teaching to fit the different learning styles and abilities of students, ensuring everyone can learn effectively.
- Teachers should receive ongoing training to better understand and address the unique needs of all students in the classroom.
- Technology tools and apps can help students learn at their own pace and make learning more personalized.

- Group activities where students can work together help them learn from each other and develop social skills.
- Practical, hands-on tasks, like experiments or projects, allow students to learn through doing, catering to different learning styles.
